

## Annual Report

- 2020-2021 Served 61 families
  - 2018-2019- 20 families, 2019-2020 35 families
- 2020-2021 83 ISSTs
  - 2018-2019 -46 ISSTs, 2019-2020 62 ISSTs
- 2020-2021 69 referrals
  - 70% became open referrals
  - 12% denied
  - 6% No contact was made
  - 12% are referral which are on hold

- Performance Measures
  - CMP children who remain in their home during CMP involvement
    - Goal = 80%, Actual = 91%
  - CMP children with improved school attendance rates
    - Goal = 60%, Actual = 67%
  - CMP Medicaid eligible children/youth who received a behavioral health screen
    - Goal = 75%, Actual = 98%
- Process Measure
  - Met all 5

#### **ISST**

- 2020-2021
  - 70% of referrals included mental health or behavior concerns
  - 38% included family resources
  - 26% included attendance
- The most referrals were from schools with DHS next

- 2021-2022
  - 2 referrals for 2021-2022
    - Unable to make contact on both
  - At least 11 carryovers from 2020-2021

### Budget

- Total Expenditures in 2020-2021
  - Personnel \$40,711
  - Operations \$2,115
  - Prevention Programming \$0
  - Discretionary \$1,038
- Total = \$43,924
  - Budgeted = \$56,898.20
  - \*\* Only category which was over budget was goods and services to families by \$38

- 2021-2022 Budget
  - Revenue is approx. \$61,844
    - Will find out actual about in Sept.
  - Carryover from 2020-2021 = \$72,105
  - Total = \$61,987.96
    - Personnel = \$48,157.96
    - Operations = \$8,780
    - Prevention Programming = \$1,000
    - Discretionary = \$4,050

## Mentoring Program


- Received grant for \$14,000 from NHP for this program
- Our first volunteer is done with training
- Working on sending in referrals for youth
- Youth must come through ISST to be eligible for this service
- If you have a possible referral, please complete ISST referral form
- Youth from 13-23
- Know someone who might be interested? Please give me their contact information
- Goal is to serve 10 youth in 2021-2022

## Food Delivery

- Received grant for 9,200 from NHP for program
- Working with each school to determine interest and ability to have a food emergency box.
  - Ideally, boxes will be at every school for emergency food needs of a family.
    - Family will complete intake form for emergency food and either CMP or PFC will follow-up with the family.
- Food delivery will occur on the Second Monday of the month and 2 weeks following for families outside of Burlington.
  - Family must complete intake form which states why they need delivery.
  - Working with schools and other local organizations to provide alternative pick up locations in communities.
  - Goal is to have everything secured and set up September.

#### School Climate

- Each school has approximately \$10,000 for the 2021-2022 school year for school climate related items.
- Please reach out to Jessica for more information and coordination with the school.
- After the 2021-2022 school year, there will be one more grant year.
